3. All cases will remain locked throughout the show. The exhibit chair and staff will be available during setup and teardown to assist you.
4. Neither the San Diego Mineral and Gem Society nor the Liberty Station Conference Center will assume any responsibility for lost, damaged, or stolen material during the show. Each exhibitor must provide their own insurance and/or assume their own risk. After hours the conference center will be locked with a security alarm set.
5. Please provide your name with the exhibit. If you are a club or society or a member of one, please provide that information.
6. Your exhibit may not be used for commercial promotion or advertising, but you are permitted to put contact information and/or a business card in the display. Price information is not permitted.
7. We ask that all major items in your display be labeled appropriately. Labels should be neat and legible, and indicate the kind of material and source where appropriate.
8. Please provide your own liners and risers. Unfortunately we do not have them.
